CONSENT TO THE PROCESSING OF PERSONAL DATA FOR DIRECT MARKETING PURPOSES

1. By providing freight transportation as well as other related services, AB LG CARGO (below – Company) conducts direct marketing (organizes various events, campaigns, sends newsletters, conducts customer satisfaction surveys, analyses customer needs, etc.).
2. If you wish to receive information conveyed by us, we require your consent. We would like to inform you that the following personal data will be processed for direct marketing purposes: name, last name, phone number, e-mail address and legal entity name, legal entity code, legal entity phone number, legal entity e-mail address, address of the head office of the legal entity, details of the authorised person of the legal entity if the data of the legal entity is to be submitted.
3. Your personal data processed for direct marketing purposes will be stored for 5 years following your consent or until the withdrawal of your consent. In order to make sure that our offers are still relevant, we will periodically (approximately every 4-5 years) ask for your consent on direct marketing.
4. Please, be informed that you shall have the right to:
 - ✓ access your personal data and the way they are processed (the right of access);
 - ✓ request your personal data is rectified or supplemented with regard to the purpose for handling of personal data (the right to rectification);
 - ✓ erase your personal data or suspend data processing actions (except for storage) where there is no other legal ground for the processing (the right to erasure and the right “to be forgotten”);
 - ✓ request the data Controller to restrict processing of personal data in the circumstances set out in the laws (the right to restriction);
 - ✓ data portability (the right to data portability);
 - ✓ lodge a complaint to the State Data Protection Inspectorate if you consider your rights to have been violated;
 - ✓ object to processing of your personal data or withdraw your prior consent at any time; however, in the present case, we will not be able to provide you with all of the relevant information on the services and discounts provided by Company.
5. Upon withdrawal of the prior consent, your personal data will be erased.
6. If you agree to receive our direct marketing communications, whenever we send you our advertisements or call, we will provide you with the ability to refuse to receive our advertisements in the future in a simple manner. You can also withdraw your consent by contacting us at the following e-mail address: letter@litrail.lt.
7. The Controller is entitled the right to assign other processors for processing your personal data. However, prior to assigning of other processors, the Controller must evaluate their reliability. Reliable processors are considered to be processors having the necessary expertise and resources to ensure the security of processed data and are able to prove it. Agreements for data processing must be signed with the above-mentioned processors.
8. **We would like to inform you that you have the right to object processing of your personal data for direct marketing purposes.** We would like to note that refusal to give consent will not have any adverse effects on you.
